To change your legal address, the Address of Record fields on the Legal Identity Report (MSHA Form 2000-7) must be updated. A separate form must be completed for each mining operation of the operator. You can file an updated report online at <http://www.msha.gov/forms/elawsforms/2000-7.htm> or mail the information to your District Office as required by 30 CFR 41.
