The operator has used doors in lieu of overcasts at crosscuts #81 and #84 of the 6 North Mains in the track entry.

Doors in lieu of overcasts are not sufficient to properly control flow of critical ventilation due to human error, and high maintenance demands which allows leakage of vital airflow thereby creating losses of ventilation current to the working sections.
