The Operator failed to preserve an accident scene, without investigation of the accident to determine the cause and precautions to be implemented to prevent the re-occurrence of similar accidents. A roof fall occurred on the Longwall on 12.04.2009, #1 entry, at spad 28+33, second shift. The fall was reported on 12.05.2010, as "fell out between the bolts on the stage loader and blocked part of the primary escapeway". Production reports, provided following the investigation of a mine explosion on 04.05.2010, reveal that the evening shift drilled and shot the fall four times to free the stage loader. The production report shows the fall to be 20'X40'X7. Upon freeing the stage loader, the Operator resumed mining, destroying all evidence of the accident. The longwall (050/ MMU) face retreated past the accident (fall), destroying/preventing the accident from ever being
