- 3 ATTORNEY BAXTER:
- 4 Let's go on the record. My name's Derek
- 5 Baxter. Today is June 18th, 2010. I'm with the
- 6 Office of the Solicitor, U.S. Department of Labor.
- With me is Jasey Maggard, an accident investigator
- 8 with the Mine Safety and Health Administration, MSHA,
- 9 an agency of the United States Department of Labor.
- 10 Also present are several people from the State of West
- 11 Virginia. I ask that they state their appearance for
- 12 the record.
- 13 MR. FARLEY:
- 14 I'm Terry Farley, with the West Virginia
- 15 Office of Miners' Health, Safety and Training.
- 16 MS. MONFORTON:
- 17 And I'm Celeste Monforton, and I'm with
- 18 Governor Manchin's special team.
- 19 ATTORNEY BAXTER:
- 20 And Mr. Maggard, Mr. Farley and Dr.
- 21 Monforton will be conducting the questioning today.
- 22 All members of the Mine Safety and Health Accident
- 23 Investigation Team and all members of the State of
- 24 West Virginia Accident Investigation Team
- 25 participating in the investigation of the Upper Big

- 1 Branch Mine explosion shall keep confidential all
- 2 information that's gathered from each witness who
- 3 voluntarily provides a statement until the witness
- 4 statements are officially released. MSHA and the
- 5 State of West Virginia shall keep this information
- 6 confidential so that other ongoing enforcement
- 7 activities are not prejudiced or jeopardized by a
- 8 premature release of information.
- 9 This confidentiality requirement shall
- 10 not preclude investigation team members from sharing
- information with each other or with other law
- 12 enforcement officials. Your participation in this
- interview constitutes your agreement to keep this
- information confidential.
- 15 Government investigators and specialists
- have been assigned to investigate the conditions,
- events and circumstances surrounding the fatalities
- 18 that occurred at the Upper Big Branch Mine-South on
- 19 April 5th, 2010. The investigation is being conducted
- 20 by MSHA under Section 103(a) of the Federal Mine
- 21 Safety and Health Act and the West Virginia Office of
- Miners' Health, Safety and Training. We appreciate
- your assistance in this investigation.
- 24 You may have your personal attorney
- 25 present during the taking of this statement, or

- another personal representative, if MSHA has permitted
- 2 it, and may consult with your attorney or the
- 3 representative at any time. Do you have a personal
- 4 representative here today?
- 5 MR. MILLS:
- 6 No.
- 7 ATTORNEY BAXTER:
- 8 Okay. Your statement is completely
- 9 voluntary. You may refuse to answer any question and
- 10 you may terminate your interview at any time or
- 11 request a break at any time.
- 12 Since this is not an adversarial
- proceeding, formal Cross Examination will not be
- 14 permitted. However, your personal legal
- 15 representative may ask clarifying questions as
- 16 appropriate.
- 17 Your identity and the content of this
- 18 conversation will be made public at the conclusion of
- 19 the interview process and may be included in the
- 20 public report of the accident, unless you request that
- 21 your identity remain confidential or your information
- 22 would otherwise jeopardize a potential criminal
- 23 investigation. If you request us to keep your
- identity confidential, we will do so to the extent
- 25 permitted by law. That means that if a Judge orders

- 1 us to reveal your name or if another law requires us
- 2 to reveal your name or if we need to reveal your name
- for other law enforcement purposes, we may do so.
- 4 We request that you refrain from
- 5 discussing your statement with others who may be
- 6 interviewed. Also, there may be a need to use the
- 7 information you provide to us or other information
- 8 we'd ask you to provide in the future in other
- 9 investigations into and hearings about the explosion.
- 10 Do you understand?
- 11 MR. MILLS:
- 12 Uh-huh (yes). Yes.
- 13 ATTORNEY BAXTER:
- 14 Okay. And do you have any questions?
- 15 MR. MILLS:
- 16 No.
- 17 ATTORNEY BAXTER:
- 18 After the investigation is complete, MSHA
- 19 will issue a public report detailing the nature and
- 20 causes of the fatalities in the hope that greater
- 21 awareness about the causes of accidents can reduce
- their occurrence in the future. Information obtained
- 23 through witness interviews is frequently included in
- these reports. Since we will be interviewing other
- individuals, we request that you not discuss your

- 1 testimony with any person aside from your personal
- 2 representative or counsel.
- 3 A court reporter will record your
- 4 interview. Please speak loudly and clearly. If you
- 5 do not understand a question asked, please ask me to
- 6 rephrase it. Please answer each question as fully as
- you can, including any information you've learned from
- 8 someone else.
- 9 I would like to thank you in advance for
- 10 your appearance here. We appreciate your assistance
- in this investigation. Your cooperation is critical
- in making the nation's mines safer.
- 13 After we've finished asking questions,
- 14 you'll have an opportunity to make a statement and
- provide us with any other information you believe to
- be important. If at any time after the interview you
- 17 recall any additional information that you believe
- might be useful, please contact Norman Page at the
- 19 telephone number or e-mail address provided to you.
- 20 MR. FARLEY:
- 21 Okay. Are you ready?
- 22 ATTORNEY BAXTER:
- 23 Yes.
- 24 MR. FARLEY:
- 25 Nathan, again, I'm Terry Farley with the

- 1 Office of Miners' Health, Safety and Training. I want
- 2 to advise you also that the West Virginia Coal Mine
- 3 and Health and Safety Regulations also protect miners
- 4 against any kinds of discrimination you might suffer
- 5 as a result of participating in this interviews ---
- 6 interview. And I'm going to pass along some contact
- 7 information in case you need to file a claim.
- 8 MR. MILLS:
- 9 Okay.

- 12 AS FOLLOWS:
- 13
- 14 EXAMINATION
- 15 BY MR. FARLEY:
- 16 Q. Nathan, can we begin by asking you to state your
- full name, your home address and a phone number,
- 18 please?
- 19 A. Nathan Wyatt Mills.
- 20 OFF RECORD DISCUSSION
- A. Wyatt, W-Y-A-T-T.
- 22 BY MR. FARLEY:
- 23 Q. Home mailing address, home address and a phone
- 24 number, if you don't mind, please.
- 25 A. (b) (7)(C) ---.

- 1 OFF RECORD DISCUSSION
- 2 (b) (7)(C)
- 3 (b)(7)(C) . And home phone is (b)(7)(C)
- 4 BY MR. FARLEY:
- 5 Q. Okay. How long have you been a coal miner?
- 6 A. Since 2000 --- like either '04 or '05.
- 7 Q. Okay. About five or six years; is that right?
- 8 A. Yeah.
- 9 Q. Where have you worked during that five to six-year
- 10 period?
- 11 A. I've worked at Elk Run. I've worked at Eastern,
- 12 for Harris Number Four.
- 13 Q. Uh-huh (yes).
- 14 A. I've worked at Magnum, Butler.
- 15 Q. Uh-huh (yes).
- 16 A. And I worked at Marfork, Performance and back to
- 17 Elk Run.
- 18 Q. Okay. Now, you're at Elk Run now?
- 19 A. Yes.
- 20 Q. Okay. Did you transfer back to Elk Run after the
- 21 explosion on April 5th?
- 22 A. That's where I got transferred to.
- 23 OFF RECORD DISCUSSION
- 24 A. That's where I got transferred to.
- 25 BY MR. FARLEY:

- 1 Q. Okay. How long did you work at UBB, Performance
- 2 UBB Mine, prior to the explosion?
- 3 A. I started there in May of the previous year.
- 4 Q. So 2009?
- 5 A. Yes.
- 6 Q. Okay. What was your occupation there at UBB
- 7 during that period of time?
- 8 A. I was an electrician.
- 9 Q. Okay. Did you work on any particular section as
- 10 an electrician?
- 11 A. I started there on third shift on the Three
- 12 section. It's on --- we trammed UBB on the left side
- of the mountain ---.
- 14 Q. Would that be on the south end, south end of the
- 15 mine?
- 16 A. I believe that's what they call it.
- 17 Q. Okay. And did you portal at the UBB Portal at
- 18 Montcoal?
- 19 A. Yes.
- Q. Okay. And was Three section also known as the
- 21 portal section later?
- 22 A. Yeah. They changed that later on.
- 23 Q. Okay.
- A. That used to been Three section, but I think they
- 25 changed it to Portal section.

- 1 Q. Okay. Now, you started there on your midnight
- 2 shift. Did you move to some other shift at some other
- 3 section?
- 4 A. Yeah. I went to Two section on the other side of
- 5 the mountain. And I was up there for about --- I was
- 6 18 months on dayshift. And they said they had a
- 7 problem with the longwall flooding out and they pulled
- 8 us off there, and I get sent back up to Three, Three
- 9 section.
- 10 Q. Okay. Now, when you say Two section, ---
- 11 A. Yeah.
- 12 Q. --- would that be the section now known as
- 13 Headgate 22?
- 14 A. No.
- 15 O. Would that be ---?
- 16 A. Whenever Two section was down in here
- 17 (indicating).
- 18 O. Okay. All right. You're pointing to the ---
- 19 A. I'm pretty sure.
- 20 Q. --- to what's called the crossover entries, which
- are immediately outby the mouth of the longwall panel?
- A. Yeah, I'm thinking we come up here (indicating),
- 23 make this turn, come up, and we was in here somewhere.
- 24 Q. Okay. Now ---.
- 25 A. Right about here.

- Q. Now, do us a favor, if you can. When you're
- 2 referring to a place on the map, ---
- 3 A. Uh-huh (yes).
- 4 Q. --- sometimes it's difficult to describe where you
- 5 are. So if you would, please, just take a marker and
- 6 mark the area and draw a line up from it and specify
- 7 you worked here from whenever to whenever.
- 8 ATTORNEY BAXTER:
- 9 And we'll mark this map as Mills' Exhibit
- 10 One.
- 11 (Mills' Exhibit One marked for
- 12 identification.)
- 13 BY MR. FARLEY:
- 14 Q. Okay.
- 15 A. Like this across ---?
- 16 Q. Yeah. Just draw --- draw a circle around the
- 17 whole thing, if you like.
- 18 A. I'm circling ---. I don't know when the dates
- 19 was.
- 20 Q. Did you go there in 2009?
- 21 A. Yes.
- 22 Q. So sometime in 2009?
- A. I can't remember when, exactly.
- 24 Q. Okay.
- 25 A. I can't remember.

- 1 Q. Okay. Anyhow, you've indicated that you were
- 2 there about three ---?
- 3 A. Two, maybe --- maybe a month.
- 4 Q. Maybe a month?
- 5 A. Maybe a month.
- 6 Q. Okay. All right. Now, let's --- let's just move
- forward, then, to 2010. What area of the mine did you
- 8 work in, in 2010?
- 9 A. 2010, I was down in here (indicating).
- 10 Q. And you're pointing to the area of the Glory Hole?
- 11 A. Yes. Right in here.
- 12 Q. Okay. You're actually ---. I think you're
- pointing to ---
- 14 A. The block split.
- 15 Q. --- to the area where the 22 Headgate belt dumps
- 16 onto ---
- 17 A. Seven.
- 18 O. --- Seven North belt?
- 19 A. Yeah.
- 20 Q. Okay. So you were working in that area this year?
- 21 A. Yeah.
- Q. Okay. What'd you do in that area?
- 23 A. Really just we took equipment. They had some
- 24 equipment up here (indicating).
- Q. Were you working on a conveyor belt construction

- 1 or something like that?
- 2 A. Yeah. What we done is we split these two blocks
- 3 right here, to make this beltline laid up with Seven
- 4 North.
- 5 Q. Okay. Now, when you say, right here, again you're
- 6 pointing to ---
- 7 A. The block.
- 8 Q. --- the area in the vicinity of where 22 Tailgate,
- 9 22 Headgate belt dumps onto the Seven North belt?
- 10 A. Yeah. Yeah, this would be it right here.
- 11 Q. Okay. Now, if I'm following you correctly, you
- were working --- you've been working in --- you were
- working in that area this year prior to the explosion?
- 14 A. Yes.
- Q. Now, were you working there up to the time of the
- 16 explosion?
- 17 A. No.
- 18 O. Okay.
- 19 A. We got big blocks split and they pulled me off
- there.
- 21 Q. Okay. Where'd they send you after that?
- 22 A. To Ellis, the new Ellis setup.
- 23 Q. Okay.
- A. And that would be ---.
- Q. You mean the area where they're going to establish

- 1 a new longwall near the Ellis Portal?
- 2 A. Yeah. Went 14 breaks in through the left. Then I
- 3 think it was about 11 breaks down.
- 4 Q. That's pretty good. That'll work. That's much
- 5 better than I can do.
- 6 A. Thank you.
- 7 Q. All right. And how long were you there before the
- 8 explosion?
- 9 A. I probably been taking equipment in from outside
- 10 at Ellis for maybe a month. We'd just, you know, get
- 11 different equipment in, ---
- 12 Q. Okay.
- 13 A. --- put cables on ---.
- 14 Q. Are you talking about section equipment,
- 15 production equipment?
- 16 A. Yes.
- 17 Q. Okay. Do you recall what you was taking in ---
- what you were taking in, in the month preceding the
- 19 explosion on April 5th?
- 20 A. Feeder. They got a feeder in and we hadn't got a
- 21 roof bolter yet. And we took the miner in, I'm pretty
- 22 sure in that time frame.
- 23 Q. Okay.
- A. But I'm thinking we got our last shuttle car in,
- in the time frame, too.

- 1 Q. Okay. Now, did you transfer it in?
- 2 A. Yes.
- Q. What'd you use for the power source, something on
- 4 the surface or ---?
- 5 A. A D box, yeah. And we call it a move box.
- 6 Q. Okay. If I would show you a blow-up map of that
- 7 Ellis Portal area, could you trace the travel route
- 8 you took with that equipment when you moved it in?
- 9 A. Yeah, I should be able to.
- 10 OFF RECORD DISCUSSION
- 11 ATTORNEY BAXTER:
- 12 And we'll mark this ---. Are we back on
- 13 the record? We'll mark this as Mills' Exhibit Two.
- 14 (Mills' Exhibit Two marked for
- 15 identification.)
- 16 BY MR. FARLEY:
- 17 Q. I never seen this before. Do you want to take a
- 18 marker and just show me which way you took that
- 19 equipment in? Why don't you use this. You want to
- 20 use a ---? Tell me which way you brought that
- 21 equipment in, if you can.
- 22 A. Okay. Down this way. There was no regulator.
- 23 Q. Okay.
- A. So that's not here. Come up through here, all the
- 25 way up. Let me see. Is that double doors? From I

- 1 think two breaks in ---.
- Q. Just keep --- keep your line moving.
- 3 A. I'm pretty sure down this way.
- 4 Q. Okay. Now ---?
- 5 A. It was either --- let's see.
- 6 Q. Well, did you go up the track entry?
- 7 A. No, they put the beltline, belt structure in
- 8 through here.
- 9 Q. Okay. When you say, in through here, you --- as
- 10 you said earlier, you would come in the area of Ellis
- 11 Portal, going up 14 crosscuts and hang a left?
- 12 A. Yeah. Come down here and that's where we dropped
- 13 it.
- Q. And that belt you're referring to be would be in
- 15 the ---
- 16 A. This right here.
- 17 Q. --- middle entry?
- 18 A. Yeah.
- 19 Q. Which where you make the turn would be the Number
- 20 Three or Four --- Three entry, I believe; right?
- 21 A. Yes.
- 22 Q. Okay. All right. Now, when you brought this ---
- when you trammed this equipment in, did anybody help
- 24 you?
- 25 A. Yes.

- 1 Q. Who? Who usually helped you?
- 2 A. Usually Rick Nicolau ---.
- 3 Q. What was his position?
- 4 A. He was the dayshift chief.
- 5 Q. Okay. Now, this last, last month prior to the
- 6 explosion, when you were working in this area, who was
- 7 your immediate supervisor? Who'd you report to every
- 8 day?
- 9 A. Everett Hager and Rick Nicolau.
- 10 Q. Okay. Rick Nicolau was your maintenance foreman?
- 11 A. Yeah. Well, he's the dayshift chief.
- 12 Q. Okay.
- 13 A. He's over at the hole.
- Q. All right. So you were working dayshift, ---
- 15 A. Yes.
- 16 Q. --- prior to the explosion for about a month?
- 17 A. Yes.
- 18 O. Okay. When you trammed the equipment in, in that
- 19 entry from the Ellis Portal, was the air always ---
- 20 which way was the air moving?
- 21 A. The best I can recall, the air was moving out.
- 22 Q. Outby direction toward the ---?
- A. Outby.
- Q. Does that mean it would've been hitting you in the
- 25 face as you were advancing inby ---?

- 1 A. As I'm going inby.
- Q. Okay. All right. Now, prior to moving to the
- 3 Ellis Portal area about a month before the explosion,
- 4 did you ever work on the longwall ---
- 5 A. No.
- 6 Q. --- at any time?
- 7 A. No.
- 8 Q. Did you visit it for any reason?
- 9 A. When I first went up to --- well, on that side of
- 10 the mountain ---
- 11 Q. Uh-huh (yes).
- 12 A. --- they had me go up there and cut a belt head
- out. It was just the whole belt head and one of the
- bolts got loose, so I could take it out of there. And
- it was --- you know, it was way back in here
- 16 (indicating) and ---.
- 17 Q. When you say, way back in here, you got any idea
- 18 where that might've been?
- 19 A. At that time, I have no idea.
- 20 Q. Okay. Was it somewhere where the longwall face
- 21 was at the time?
- A. No. No, it was on their beltline.
- 23 Q. On the longwall beltline?
- A. Yeah. That was way up, up through there.
- Q. Okay. So this would be outby where they were

- 1 mining then; right?
- 2 A. Yes.
- Q. Okay. Prior to your month at Ellis, did you ever
- 4 work on the 22 Headgate section?
- 5 A. I'd filled in like once or twice for an
- 6 electrician over there.
- 7 Q. When you say you filled in, was that like a
- 8 production section?
- 9 A. Yes.
- 10 Q. Okay. When they were running coal? Do you
- 11 remember when that was?
- 12 A. No.
- Q. This year? Okay. Do you remember who the section
- 14 boss was at the time?
- 15 A. Pat Hilbert.
- Q. Pat Hilbert was the dayshift, evening shift or do
- 17 you recall?
- 18 A. I remember I doubled back for it and that was the
- 19 evening shift.
- 20 Q. Okay. Do you remember if they were having any
- ventilation problems on 22 Headgate there?
- 22 A. Not that I know of. I mean ---.
- 23 Q. Okay. All right. Do you remember any --- any
- 24 problems with the roof and the ribs or the floor, the
- 25 mine floor?

- 1 A. No. But when I did get up there toward that
- 2 evening, the evening shift, ---
- 3 Q. Uh-huh (yes).
- 4 A. --- I noticed they had a lot of water in the
- 5 return side of their section.
- 6 Q. Now, when you point to the return side, would that
- 7 be on the ---. You're pointing to the right side of
- 8 the section, which would be the Number Three entry
- 9 there?
- 10 A. They had a big water hole there. And they had ---
- 11 you know, it wasn't too bad of a section overall.
- 12 Q. Okay. Now, this may seem like a silly question,
- but when you saw the water on the 22 Headgate section,
- 14 did you see any bubbles in it? Did it bubble at any
- time, as if air were escaping?
- 16 A. Yes. Yeah. Yeah, it bubbled.
- 17 Q. Okay.
- 18 A. I didn't have a methane monitor or methane
- 19 detector.
- 20 Q. Okay. And, you know, while you were working on 22
- 21 Headgate section, did you --- were you around at any
- time when someone's monitor detected some quantity of
- 23 methane in any of the working faces?
- 24 A. No.
- Q. Okay. And during your conversations with people

- on the Headgate 22 section, did anyone refer to having
- detected some methane in any of the working faces?
- 3 A. When I was at UBB, I never heard of any methane
- 4 problems, no.
- 5 Q. And you ---?
- 6 A. I would hear of things --- everything, because I
- 7 like to keep track of that, ---
- 8 O. Sure.
- 9 A. --- but I never heard of any methane problems.
- 10 Q. Now, and let me make sure I got --- get you right
- on this. You were at UBB for about a year before the
- 12 explosion?
- 13 A. Yeah.
- 14 Q. You say you didn't --- you never heard of any
- 15 methane problem?
- 16 A. Me personally, no.
- 17 Q. Okay. All right. Anybody else --- nobody
- 18 mentioned any --- any issues anywhere?
- 19 A. Just they had mentioned low air, you know. Just
- they'd talk about it.
- Q. When they say low air, did they link that with a
- 22 particular section?
- 23 A. Not really. Just, you know, mostly I would be in
- the bath house with the Headqate 22 guys.
- 25 Q. Okay.

- 1 A. Yeah. Those was all ---
- 2 Q. Okay.
- 3 A. --- ever talked about.
- 4 Q. All right. Okay. In the month preceding the
- 5 explosion on April 5th, when you were working at the
- 6 Ellis Portal area, were you ever removed from the mine
- 7 because of a ventilation problem that you know of?
- 8 A. Not the month prior. I'm thinking maybe a month
- 9 or two. We was --- we was somewhere down in here
- 10 moving equipment.
- 11 Q. When you said, we're somewhere down in here,
- 12 you're ---?
- 13 A. When we was pulling the equipment down to the
- 14 Glory Hole ---.
- 15 Q. Moving equipment from the Glory Hole area?
- 16 A. Well, we was moving it from up in here, down this
- 17 way.
- 18 Q. Okay. Now, when you ---. Let me, let me ---.
- 19 You're referring to the area on --- area on the map in
- the vicinity of 78 Switch; is that right?
- 21 A. No, we wasn't that far up. This belt head right
- here.
- Q. Six North belt head? Is that what you're pointing
- 24 to?
- 25 A. Yes.

- 1 Q. Okay. When were you moving that --- what
- 2 equipment were you moving from there?
- 3 A. We was moving a miner, bolter and a shuttle car
- 4 and a feeder. And that day, I think we was moving the
- 5 feeder.
- 6 Q. Okay. Where did you move this equipment to?
- 7 A. We moved it down here.
- 8 Q. Okay.
- 9 A. We moved it to down in here.
- 10 Q. Okay. You've indicated --- you've drawn a ---
- 11 marked a location shortly outby Crosscut 130 on Seven
- 12 North?
- 13 A. Yes.
- Q. And that's where the equipment was moved to that
- 15 you were just referring to from ---?
- 16 A. Yes.
- 17 Q. Okay. Now, this equipment that you moved, what
- 18 shift did you move it on?
- 19 A. It's dayshift.
- Q. Dayshift?
- 21 A. Yes.
- 22 Q. Okay. Do you know --- do you recall which entry
- 23 you moved the equipment through? Did you tram it?
- 24 A. Mine ---.
- Q. Did you move it on a track-mounted car?

- 1 A. It was trammed, but I just --- I put the cat heads
- on, stuff like that.
- 3 OFF RECORD DISCUSSION
- 4 A. The cat heads. On in the face --- the face to
- 5 make sure it run right, but other than that, you know,
- 6 I didn't ---.
- 7 BY MR. FARLEY:
- 8 Q. Was someone else actually tramming the equipment?
- 9 A. Yeah. There was, I think four or five of us up
- 10 there.
- 11 Q. Okay. And that was sometime this year, ---
- 12 A. Yeah.
- Q. --- at least a month prior to the explosion?
- 14 A. No. It was longer than a month prior.
- 15 Q. Okay. Do you recall which entry was used when the
- 16 equipment was trammed?
- 17 A. It's about over your track. Right over here,
- 18 through this entry here.
- 19 Q. You think the Number Two entry, as you're
- 20 traveling the inby direction?
- 21 A. Yes. Down through here.
- 22 Q. Okay. All right. Now, which shift were you
- working when you moved this equipment?
- A. Dayshift.
- Q. Dayshift. Okay. Now, which way was the air

- 1 moving in that entry? As you were traveling inby,
- 2 what --- as you were moving inby, was the air hitting
- 3 you in the back or hitting you in the face?
- 4 A. I can't remember.
- 5 MR. FARLEY:
- 6 Okay. Okay. Did you have anything?
- 7 MR. MAGGARD:
- 8 Yeah, I guess.
- 9 EXAMINATION
- 10 BY MR. MAGGARD:
- 11 Q. I'm not real sure. Did you ever go to the
- 12 tailgate section?
- 13 A. I walked up there one time, just to see how it was
- set up. I never went to the face or anything like
- 15 that. The farthest I went was right here.
- 16 Q. And this is close to spad 24502, a couple breaks
- 17 from the crossover?
- 18 A. Yes.
- 19 Q. Okay. And how long ago was that?
- 20 A. To be honest with you, I don't know. Maybe a
- 21 month prior.
- 22 Q. What can you tell us about that area? Did you
- 23 notice anything unusual?
- A. The only unusual thing, because I crossed up this
- 25 (indicating) way and come down, was they did have a

- fall right here. And it had been cleaned up, because
- 2 it's real high right here.
- 3 Q. Was it here on the beltline or ---?
- 4 A. No, it wasn't the beltline. It was the next break
- 5 across from the beltline.
- 6 Q. Okay.
- 7 A. It would've been that area there.
- 8 MR. MAGGARD:
- 9 He's showing us a --- looks like a roof
- fall area that's already marked on the map.
- 11 BY MR. MAGGARD:
- 12 Q. Could you tell us about the --- did you see the
- 13 beltline? Did you travel through that?
- 14 A. No. There were stoppings down through here
- 15 (indicating). I couldn't see the ---
- 16 Q. Okay.
- 17 A. --- the beltline.
- 18 Q. Did you go through this intake split area right
- 19 here, (indicating) that's toward the headgate side of
- 20 the roof fall?
- 21 A. Uh-huh (yes).
- 22 Q. Could you tell anything about the air going
- through there?
- A. Not really. They had a set of double doors here
- and ---.

- 1 Q. And you're pointing to ---?
- 2 A. Let me find it here.
- Q. Okay.
- 4 A. Here. We were around ---.
- 5 Q. Was these overcasts there?
- 6 A. Yes.
- 7 MR. MAGGARD:
- 8 Okay. And this is --- he's showing where
- 9 the intake air splits and starts going to the Number
- 10 Two entry of the headgate section.
- 11 BY MR. MAGGARD:
- 12 Q. What was the condition of the doors there?
- 13 A. They were new, as far as I know. They looked in
- 14 good shape.
- 15 Q. Where they opened or closed or ---?
- 16 A. They was closed.
- 0. How did the rock dust look in the area that you
- 18 traveled in the crossover area?
- 19 A. I can't really remember dust.
- Q. How about the roof conditions and floor
- 21 conditions? See any bottom heaving in that area
- 22 or ---?
- 23 A. Just the only thing was that roof fall that I ---
- 24 Q. Okay.
- 25 A. --- kind of walked fast through.

- 1 Q. Okay. When you worked on the headgate section,
- 2 you said you subbed there for a couple --- a couple
- 3 shifts or something --- one shift?
- 4 A. Uh-huh (yes).
- 5 Q. Okay. Did you notice the miner running up there
- on the section, that ---
- 7 A. Yeah, they ---.
- Q. --- miner? And you probably already said, but how
- 9 long ago did you guess that that was?
- 10 A. I would say over a month ago.
- 11 Q. Okay. When that miner was running, could you ---
- did you notice the methane monitor on the miner?
- 13 A. No.
- 14 OFF RECORD DISCUSSION
- 15 MR. MAGGARD:
- 16 Methane monitor.
- 17 A. No, just ---.
- 18 ATTORNEY BAXTER:
- 19 Did you mean --- I'm sorry. Did you mean
- 20 a month prior to the explosion?
- 21 A. Yes.
- 22 ATTORNEY BAXTER:
- 23 Okay.
- 24 BY MR. MAGGARD:
- 25 Q. And was any ventilation controls missing or

- anything unusual you seen up there when they was
- 2 running?
- 3 A. No.
- 4 Q. Was they using curtain?
- 5 A. Yeah. There was curtain up when we went up there.
- 6 Q. All right.
- 7 A. It's well rock dusted up there, I know that.
- 8 Q. Did you travel the beltline in the Number One
- 9 entry at all?
- 10 A. No. I think the track was brought in here
- 11 (indicating) somewhere and we walked through ---.
- 12 Q. Are you talking the track that's probably
- somewhere midway, like at spad 24401's where you
- 14 pointed?
- 15 A. It's around there, that area.
- 16 O. Around there.
- 17 A. But we walked the rest of the way.
- Q. Have you ever had to do work on Five North around
- 19 the belt starter box or Six North starter box? You
- 20 ever visited those areas around the head drives
- 21 or ---?
- 22 A. Six North I've looked at. Five North ---.
- Q. It's probably off this map, but we have this
- 24 Exhibit One map, but ---.
- 25 A. No.

- 1 Q. Do you remember anything --- can you tell us
- anything about any belts you traveled or any head
- drives you stopped at? Tell us a little bit what you
- 4 seen. I mean ---.
- 5 A. This belt head, Seven North belt head, you know,
- 6 it was nasty conditions. Other than that, you know,
- 7 just a belt head underground.
- 8 Q. Yeah. Did they have a lot of dropoffs?
- 9 A. Well, where --- this is what was told to me, where
- this (indicating) right here was the longwall belt
- 11 before, they had a lot of gob under --- underneath
- 12 this beltline. It was real thick. It was
- waterlogged, so it was real soupy. Other than that,
- 14 you know, it was just --- this whole beltline is nasty
- from what I know, you know.
- 16 Q. How was the rock dusting?
- 17 A. They rock dusted good up in that area.
- 18 O. Just under the bottom belt, though, was a lot of
- 19 qob and stuff?
- 20 A. Well, it was --- I would say it's probably three-
- 21 and-a-half foot deep, you know, just mud.
- 22 Q. Any other belts you visited in the mine, ---
- 23 A. I've went to ---.
- Q. --- other than going down the track entry on
- 25 toward Ellis?

- 1 A. I went to the 42 Break belt head, and we had to
- 2 change a bearing on it.
- 3 O. How did that belt look? Which belt was that?
- 4 A. Whatever 42 Break's at. It's probably ---
- 5 well ---.
- 6 O. Five North belt head?
- 7 A. That's possibly it.
- 8 Q. Okay.
- 9 A. All I know it as is 42.
- 10 OFF RECORD DISCUSSION
- 11 A. All I know it as is 42 Break head.
- 12 BY MR. MAGGARD:
- 13 Q. Okay. How did that --- what you could see of that
- 14 beltline, how did it look?
- 15 A. It was white as the walls ---.
- 16 Q. And they just recently rock dusted it, or
- 17 could ---?
- 18 A. It didn't look like it. It looked like old rock
- 19 dusting, but it was just --- it was a dry area. It
- was a good looking belt head.
- Q. Have you ever been up in the Glory Hole area in
- the north part of the mine?
- 23 A. Very little.
- Q. Do you recall anything about that area, anything
- about the roof conditions, bottom heaving?

- 1 A. Just spooky.
- Q. Where did you go to up in there? What was you
- 3 doing up in there?
- 4 A. They had a parts' car left in that area that I
- 5 went and got parts for --- parts off of.
- 6 Q. Okay. And how was the ventilation up in that
- 7 area? Was it hot up there or do you recall anything
- 8 about it or ---?
- 9 A. From what I recall, it, you know, seemed ---
- seemed like there was good ventilation, because there
- 11 was a set of doors down here (indicating) or a
- 12 stopping with a man door in it down here. And we had
- to go through that and go up to it, and it was cool on
- 14 that side of the door.
- Q. Was that like in one of these (indicating)
- 16 entries, like ---
- 17 A. It would be --- it was in the track entry.
- 18 Q. In the track entry. Is that like Number ---
- 19 Number Four entry?
- 20 A. It would be --- it would be this entry right here,
- 21 I believe, ---
- 22 Q. Okay.
- 23 A. --- which would be Number Four.
- Q. All right. Okay. Where else in the mine have you
- 25 worked at? Have you visited the longwall? I don't

- 1 recall what you said about that.
- 2 A. I was at the longwall when I first went over there
- 3 to cut a belt head loose so they could drag it out.
- 4 Other than that, no.
- 5 Q. And do you recall anything about the longwall,
- 6 what you seen? What part --- where do you think they
- 7 was at when you was --- had visited there?
- 8 A. I wish I had a list of the belt heads I cut out,
- 9 so I could guess. I would say that I was probably
- 10 right in here.
- 11 Q. You're talking about around Break 40 of the ---?
- 12 A. Maybe. Maybe it wasn't that far. I think --- I
- don't know.
- Q. Do you recall anything about the roof conditions
- in this --- in that area that you went to, on the
- 16 headgate side?
- 17 A. I know they had a lot of jacks, sand jacks set up
- 18 the beltline, and that a lot of them ---. No, that's
- 19 not the only thing. You could tell there had been a
- lot of weight in the area.
- 21 Q. Okay.
- 22 A. And that was also on this (indicating) side. They
- 23 had an old beltline going up this way and they had a
- lot of weight. And the sand jacks ---.
- Q. Do you ever have to do any kind of examination on

- 1 equipment or anything?
- 2 A. Just when I first started, they did. And then the
- 3 longer I was there, the less I've done.
- 4 Q. Did you ever do any examinations over at the new
- 5 construction that you was doing on the --- by the
- 6 Ellis Portal?
- 7 A. Well, we had checked the equipment before we took
- 8 it underground.
- 9 Q. Okay. Was that equipment available --- could you
- 10 plug it in or could you energize that equipment?
- 11 A. Just through a D box, ---
- 12 Q. Okay.
- 13 A. --- or a move box.
- 14 Q. But it was available to be used the last time you
- 15 seen it or not?
- A. The last time that I'd seen it, they was using it,
- 17 but ---.
- 18 Q. What was they doing?
- 19 A. They was cutting a belt head overtop of the track.
- 20 Q. Okay. Could you maybe mark that area in? I don't
- 21 know --- maybe make a marking like you did on that map
- 22 right here on Exhibit Two.
- 23 A. Let me think.
- Q. Maybe use this pink marker this time.
- 25 A. Okay. It would be cut --- was cutting this way to

- 1 set a belt head over in here, to give the clearance
- 2 under the belt from the track.
- 3 MR. FARLEY:
- 4 Could you maybe draw an arrow or make ---
- 5 make that an arrow so we know the direction they were
- 6 cutting, please?
- 7 A. Okay.
- 8 BY MR. MAGGARD:
- 9 Q. And when was the last time they was working on
- 10 that, if you know?
- 11 A. The day of the explosion.
- 12 Q. The day of the explosion? Okay. Did you work the
- day of the explosion?
- 14 A. Yes.
- Q. And where was you at? Was you in this
- 16 (indicating) area?
- 17 A. Yes. I was down here, actually (indicating).
- 18 O. Okay.
- 19 A. Go ahead.
- 20 Q. Go ahead. What was you doing in that --- down
- 21 south of the ---?
- 22 A. Right in here. I was right in here. I put a door
- on a scoop and on down I put a ---.
- Q. Could you maybe put down scoop, door on the scoop
- or something like that? Door? Okay. All right.

- 1 A. It was a good ways on down through ---.
- 2 OFF RECORD DISCUSSION
- 3 A. It was a good ways on down through there, which
- 4 would be --- we put a kVA probably eight or nine
- 5 breaks further down through here.
- 6 MR. MAGGARD:
- 7 Okay. Maybe we could mark that on this
- 8 map on this 500-scale map.
- 9 ATTORNEY BAXTER:
- 10 If you can speak up, ---
- 11 A. Okay.
- 12 ATTORNEY BAXTER:
- 13 --- so she can hear better.
- 14 A. Okay.
- 15 ATTORNEY BAXTER:
- 16 If you want, you can take the map down
- 17 there, so ---
- 18 A. Okay.
- 19 ATTORNEY BAXTER:
- 20 --- the reporter can hear what you're
- 21 saying.
- 22 MR. MAGGARD:
- 23 He's going to mark a power center that
- they would stop, that day of the accident.
- 25 ATTORNEY BAXTER:

- 1 Let's mark this as Mills' Exhibit Three.
- 2 (Mills' Exhibit Three marked for
- 3 identification.)
- 4 A. I would say that kVA was right in here
- 5 (indicating).
- 6 BY MR. MAGGARD:
- 7 Q. And what time of day --- how long was you in that
- 8 area from where the scoop was to where the power
- 9 center that you said was?
- 10 A. Before what?
- 11 Q. During the day of the accident, what time did you
- 12 get done? Was you still ---?
- 13 A. I think I went in at about ten o'clock. I walked
- up there and I was up there the rest of the day.
- 15 O. Until what time?
- 16 A. Two or three o'clock.
- Q. So you was underground when it occurred or you
- 18 just got outside?
- 19 A. I walked outside at exactly three o'clock because
- 20 I didn't want to get in trouble. Walked outside. I
- opened the bath house door and the lights went out.
- 22 Well, I looked over to the right where the portals was
- and it looked like someone put a fan or something ---.
- It was blowing stuff out of there.
- Q. And was it blowing rock dust and ---?

- 1 A. Rock dust and cribs and rolling people out of it.
- 2 Q. Did you see any ---? Well, tell us what went on
- 3 when that --- after you seen that. Who was over there
- 4 at the Ellis and ---?
- 5 A. I don't quite understand.
- 6 Q. Just you went in the bath house. The lights went
- out. What did you do next? Just go through what you
- 8 seen, ---
- 9 A. I walked upstairs.
- 10 Q. --- who you spoke to.
- 11 A. I walked upstairs and talked to Rick Nicolau,
- asked him what was going on. And he said he didn't
- 13 know. And everybody just started talking on the mine
- phones, trying to get ahold of people. They thought
- they'd had a big roof fall.
- Q. And then what went on? What did they tell you?
- 17 A. It was pretty much just wait for however long. I
- couldn't put a time frame on it, but I know they
- 19 called outside and said, get us an ambulance as soon
- as you can.
- 21 Q. And who called outside?
- 22 A. I don't --- I don't know who it was.
- 23 Q. Did you see anybody enter the mine ---
- 24 A. No.
- 25 Q. --- while you was over there?

- 1 A. I seen people walking around the drift mouth but
- 2 nobody entered that I seen.
- 3 Q. And how long was you there?
- 4 A. That day?
- 5 Q. Yeah.
- 6 A. Twenty-two (22) hours.
- 7 Q. So as you was there, who was the first person you
- 8 seen arrive that wasn't already there, at Ellis?
- 9 A. I don't understand your question.
- 10 Q. Did you see anybody arrive on the property who was
- 11 --- anybody you knew?
- 12 A. Yeah, Jennifer Chandler and Craig Boggs.
- 13 OFF RECORD DISCUSSION
- 14 A. Jennifer Chandler and Craig Boggs. And what was
- 15 his name? That's the two main I can think of right
- now, but I kind of thought it was funny, because they
- 17 wasn't there, because they were mainly Elk Run. And I
- thought ---.
- 19 BY MR. MAGGARD:
- 20 Q. And what time did they get there? Do you know?
- 21 A. I don't know.
- 22 Q. And then what happened? Who else was ---?
- 23 A. And then the ambulances started showing up and
- 24 more and more people.
- 25 Q. Was there ambulances before mine rescue or mine

- 1 --- did you ever see mine rescue teams show up?
- 2 A. Mine rescue teams did show up. They suited up, I
- 3 think. They never went under. And I think they
- 4 pulled them out off the property and went up to UBB
- 5 side.
- 6 Q. And who was the --- what teams was there first?
- 7 A. I'm thinking Massey's team was there. Yeah, it
- 8 was Massey Energy's team was there first.
- 9 Q. Was there anybody underground that you knew of
- 10 during the time when you was outside that ---?
- 11 A. You mean besides these people?
- 12 Q. Yeah. Beside --- besides anybody that was
- 13 affected?
- 14 A. No.
- Q. Had you ever seen Everett Hager or Berman Cornett
- or any of those guys over there?
- 17 A. Yeah, I've seen them. Actually, I think Everett
- is the one that brought the mantrip up in here
- 19 (indicating).
- 20 MR. FARLEY:
- 21 You mean the mantrip with the deceased
- 22 people?
- 23 A. Yes. And we run down there and tried the CPR, all
- that stuff, but --- was gone.
- 25 BY MR. MAGGARD:

- 1 Q. Is there anything else you can tell us about that
- 2 night?
- 3 A. About what?
- 4 Q. About that night, what else you seen or ---?
- 5 A. I just ---. I just thought the whether was funny.
- I mean, just a lot of things was funny about that day.
- 7 It was raining, then it stopped and cleared up sunny.
- 8 Then it rained again. And they said that there's a
- 9 earthquake down Logan and everything else going ---.
- I mean, other than that, nothing out of the ordinary.
- 11 ATTORNEY BAXTER:
- 12 Do you want to go next?
- 13 MS. MONFORTON:
- 14 Sure.
- 15 EXAMINATION
- 16 BY MS. MONFORTON:
- 17 Q. Nathan, thank you for coming here today. I just
- have a couple of clarifications. You said that you'd
- 19 never heard of methane problems here, but that you
- 20 like to keep track of that or that type of thing.
- 21 What type of things did you like to keep track of,
- 22 working in the mines?
- 23 A. Just --- just overall problems in case I'm in a
- area that that would be a problem at.
- 25 Q. Yeah.

- 1 A. So that's pretty much it.
- 2 Q. Did you keep track of things like violations that
- 3 inspectors found? Did you read those or look at them?
- 4 A. The violations that the inspectors wrote was
- 5 usually put in Everett's office and people didn't like
- 6 to go in there.
- 7 Q. Okay. Now, you've asked --- now I have to ask the
- 8 question, why don't they want to go in Everett's
- 9 office?
- 10 A. Everett's a different breed of person.
- 11 Q. Okay. I understand that you probably knew some of
- the men that worked at --- on the Headgate 22 section.
- 13 You did say that you heard some of them talk about low
- 14 air.
- 15 A. Uh-huh (yes).
- 16 Q. Can you remember any specific individuals who did?
- 17 A. Not really. You know, it was just loud mouth talk
- in the bath house. I never really paid much attention
- 19 to it. The mine is the worst place in the world for
- 20 rumors and just --- just people talking.
- 21 MS. MONFORTON:
- 22 I have no other questions.
- 23 ATTORNEY BAXTER:
- 24 Okay. Terry?
- 25 RE-EXAMINATION

- 1 BY MR. FARLEY:
- Q. Did you do any weekly exams of electrical
- 3 equipment?
- 4 A. Yeah.
- 5 Q. Okay. Anything particular, such as ---?
- 6 A. Well, just whenever I was on the sections, I would
- 7 do the weekly exam on the section equipment. We'd
- 8 usually have it split up between hoot owl and
- 9 dayshift, and each shift had a couple things.
- 10 Q. Now, in the month before the explosion, did you do
- any weekly exams of electrical equipment?
- 12 A. Yeah, I'd check the pumps, the main line.
- Q. When you say the main line, do you mean from the
- 14 Ellis Portal?
- 15 A. From Ellis this way.
- 16 O. Ellis towards 78?
- 17 A. Ellis towards the Glory Hole, ---
- 18 O. Okay.
- 19 A. --- that area.
- Q. Did you find any problems?
- 21 A. No.
- Q. Did you find any violations or hazardous
- 23 conditions with the equipment?
- 24 A. I know we had a pump setting down here at the ---
- 25 underneath the starter box.

- 1 Q. Okay. And you pointed to the Glory Hole area?
- 2 A. Yes.
- 3 MR. FARLEY:
- 4 Jasey?
- 5 MR. MAGGARD:
- 6 Okay.
- 7 RE-EXAMINATION
- 8 BY MR. MAGGARD:
- 9 Q. When you did those examinations, did you record
- 10 the examinations in the record book or does someone
- 11 else?
- 12 A. I record it.
- 13 Q. So when you put --- let me ask you a question
- about idle equipment. What does that mean to you?
- 15 A. Just equipment out of service, not being used.
- 16 Q. Okay. When you mean out of service, what does ---
- 17 what do you do to put it out of service?
- 18 A. Anything that I've seen out of service at the cat
- 19 head, everything loaded up on it and wasn't being ---
- 20 nowhere near a power source.
- 21 Q. Okay. Did you ever see Chris Blanchard or Jason
- 22 Whitehead enter the Ellis Portal after the accident?
- 23 A. I know Chris Blanchard was up there, but I never
- seen him enter.
- Q. How do you know he was up there?

- 1 A. I seen him in the building. I've never seen him
- 2 go underground or suit up.
- Q. Have you ever seen him underground prior to the
- 4 accident?
- 5 A. Maybe one or two times to, you know, talk to
- 6 Everett. Where's Everett at?
- 7 Q. Okay. What did he normally do? Did he greet ---?
- 8 Did he talk to you? Did he not really ask you
- 9 anything about the condition, anything about the mine
- 10 or ---?
- 11 A. No, not really. Just, I was pretty much told to
- 12 sweep. I never really discussed anything with him,
- 13 no.
- Q. How did most of the men ---? When they arrived
- and stuff, would they say anything about what he was
- doing, what he made them do or ---?
- 17 A. No. No, not really, just ---.
- 18 Q. And when Blanchard was there after the accident,
- 19 did he have a mine light on? Did he have clothing on
- that appeared that he was going underground?
- 21 A. He always wore the Massey clothes with stripes and
- 22 everything, but that's what he wore underground, too,
- 23 so ---.
- Q. You didn't know if he was going underground or
- 25 not?

- 1 A. No. Overall I didn't know if he was --- planned
- on going underground.
- Q. Had you ever heard of any equipment, methane
- 4 monitors, being bridged out at the mine or ---?
- 5 A. Not at UBB, no.
- 6 Q. Had you ever --- during your examinations, ever,
- 7 you know, inspected or calibrated a methane monitor?
- 8 A. When I was on hoot owl, I did.
- 9 Q. And what sections was you on?
- 10 A. I was on the ---
- 11 O. Three section?
- 12 A. --- Three section, and I calibrated a methane
- monitor, but on the old Two section.
- 14 Q. And how good a shape did they normally keep their
- 15 methane monitor?
- 16 A. It was good shape. The methane monitors didn't
- 17 really seem like they was really reliable. I mean, as
- 18 for, you know, time lasting parts. You'd change a lot
- of sniffers and stuff like that off because of water.
- 20 Q. Did they keep plenty of spare parts for 'em on
- 21 hand up on the section?
- 22 A. Not on hand. Outside they usually would. They
- 23 didn't like to leave stuff up there, stuff laying
- around because, you know, they're high dollar parts.
- 25 OFF RECORD DISCUSSION

- 1 A. They're high dollar parts.
- 2 BY MR. MAGGARD:
- Q. Have you been interviewed by any of Massey's
- 4 attorneys after the accident?
- 5 A. Yeah, Massey lawyers contact me to come out from
- 6 work and come in and talk to 'em.
- 7 Q. And what did they tell you about --- or what did
- 8 they ask?
- 9 A. Just general questions. Have I seen any problems
- 10 here and there, and mostly hearsay.
- 11 Q. And did they give you any instructions on this
- interview that you're conducting?
- 13 A. That was before y'all had been conducting
- interviews, I guess. That's the first --- yeah, I
- hadn't heard of y'all conducting interviews.
- 16 Q. I'm going to switch gears again. I'm all over the
- 17 place. You said you didn't have a methane monitor or
- 18 spotter, methane spotter on, or multi-gas detector on
- 19 the headgate section when you was up there and you
- seen the water bubbling. Did you have one assigned to
- 21 you at all?
- 22 A. No.
- 23 Q. Okay.
- A. I asked for one. They said, we don't have any.
- Q. And when you were working checking pumps and doing

- 1 your electrical exam, I assume you was by yourself; is
- 2 that correct?
- 3 A. No, Bill Craddock went with me and he had a
- 4 methane detector with him.
- 5 Q. Okay. What about when you was working over at
- 6 Ellis Portal? Would they ever leave you --- leave you
- 7 alone ---
- 8 A. Just ---.
- 9 Q. --- by yourself without one or ---?
- 10 A. Just my walk-in was by myself. Just like the day
- 11 that it happened we was supposed to get a roof bolter.
- 12 That's why I was staying outside, because they called
- back and said, you know, we've got another problem
- 14 with it. We're not going to bring it today. And I
- asked Rick, what do you want me to do? And he says,
- just go up there and piddle around for the rest of the
- 17 day.
- 18 OFF RECORD DISCUSSION
- 19 A. Piddle.
- 20 BY MR. MAGGARD:
- 21 Q. When you were underground at --- did anyone ever
- 22 call you to inform you that an inspector had arrived
- 23 or ---?
- A. Me not per se. I would overhear it on a phone or
- something like that, but that never really affected me

- directly.
- Q. And where would they call from? Who would
- 3 normally call when you were around the phone and could
- 4 hear?
- 5 A. I guess the dispatcher. I don't know.
- Q. And did you ever travel with any inspectors at
- 7 this mine? Did you ever see 'em?
- 8 A. I seen an inspector.
- 9 Q. And let's --- can you remember the last time you
- 10 seen an inspector? Where was you at?
- 11 A. I was down at Ellis on the track, getting a ride
- outside, and there was two inspectors ---.
- Q. Had you ever been on the section when an inspector
- 14 arrived?
- 15 A. On the Two section.
- Q. And can you remember what you did before he got
- 17 there?
- 18 A. Did nothing, really. We --- the crew that we had
- 19 up there was, you know, they was a good crew. They
- took care of everybody, you know.
- Q. Was you working third shift or ---?
- 22 A. Dayshift.
- 23 Q. Okay.
- 24 RE-EXAMINATION
- 25 BY MS. MONFORTON:

- 1 Q. Nathan, when you were interviewed by the Massey
- 2 attorneys, did they offer to make arrangements to
- 3 accompany you, if you were interviewed by MSHA
- 4 or ---?
- 5 A. No, the only --- the first thing that they said
- 6 when I walked in is, we don't represent you, we
- 7 represent Massey. And I said, okay.
- 8 Q. Did you fill out a confidential survey that Massey
- 9 did earlier this year?
- 10 A. No, I didn't fill that survey out, but I know what
- 11 you're talking about.
- 12 Q. Okay.
- 13 A. No, I didn't fill one out.
- Q. Do you recall the last time you had SCSR training?
- 15 A. We'd just been retrained within that month.
- Q. Uh-huh (yes). And you've been a miner for a
- while, so do you notice --- have you noticed anything
- different about the way that training is done in the
- 19 last year or so compared to previously?
- 20 A. Not really. They just try to change it up a
- 21 little bit from, you know, hitting one area, like
- ventilation and stuff, to first aid more ---
- 23 Q. Uh-huh (yes).
- A. --- at the time frame. Okay. Pretty much it's
- 25 the same.

- 1 Q. Okay. What about on the SCSRs? Anything
- 2 different you notice with the SCSR training?
- A. No. We've always donned 'em, donned the SCSR and
- 4 did the two SCSR change-out and ---
- Q. Okay.
- 6 A. --- that's pretty much every year.
- 7 Q. And did you practice breathing or ---
- 8 A. Yes, they had ---
- 9 Q. --- feeling what it was like?
- 10 A. --- practice canisters that we used for five
- 11 minutes that simulate the SCSR, how it works.
- 12 Q. Okay. What were any procedures that you had at
- 13 UBB to alert your supervisor, upper management, about
- any safety concerns? What were the procedures
- 15 that ---?
- 16 A. Just --- just tell your upper management. Wasn't
- 17 really a procedure for it.
- 18 Q. Uh-huh (yes).
- 19 A. Let 'em know, ---
- 20 Q. Uh-huh (yes).
- 21 A. --- and they would try to take care of it.
- 22 Q. Did you ever have an opportunity to do that or
- 23 find the need to do that?
- A. I've told 'em about, you know, pumping some water
- off the track and stuff like that, but, you know, big

- 1 things, ---
- Q. Uh-huh (yes).
- 3 A. --- no, not really.
- 4 Q. What about the methane monitor that you requested?
- 5 How did that play out?
- 6 A. I pretty much just asked 'em, you know, if I could
- 7 have one.
- Q. Uh-huh (yes).
- 9 A. They said, we don't have 'em. We ain't got enough
- 10 for who we got now. I said, okay.
- 11 Q. Did you feel like you needed that in order to do
- 12 your job safely?
- 13 A. No. Usually I was around other people that had
- 'em, but safety in numbers, you know. I didn't see
- where, you know, I'd need one all the time, no.
- 16 Q. How do you think their refusal to provide a
- 17 spotter for you was consistent with the S1 program?
- 18 A. Don't really understand what you mean.
- 19 Q. Well, we've heard some of the other miners talk
- about S1 and Safety First.
- 21 A. Yeah.
- Q. So if you were asking for a methane monitor, how
- 23 did that kind of jive with S1? Or what is S1?
- 24 A. I didn't really think of it as S1. I was just
- 25 thinking of it as maybe a personal thing. Pretty much

- every --- everything that I've asked for up there, I
- 2 haven't got, so it wasn't nothing strange.
- 3 Q. You had not got?
- 4 A. Yeah.
- 5 Q. Okay. So you'd ask for other things and ---?
- 6 A. Yeah, you know, tools and things like that.
- 7 They'd say, yeah, yeah, yeah and ---
- 8 Q. Okay.
- 9 A. --- you'd never see it.
- 10 O. So a lot of words ---
- 11 A. Yeah.
- 12 Q. --- but no action?
- 13 A. Yes.
- 14 MS. MONFORTON:
- 15 Okay. Okay. Nothing else.
- 16 RE-EXAMINATION
- 17 BY MR. MAGGARD:
- Q. Have you ever, when you was on the section, had a
- 19 dust pump survey done on you?
- 20 A. Not me, no.
- Q. Have you ever seen the sections running dust?
- 22 A. I'm not seen 'em run dust. I've seen 'em check
- pumps.
- Q. Okay. Have you ever run across a dust pump that
- was hanging in the intake that somebody was supposed

- to be wearing that they didn't?
- 2 A. I don't jive with that. I don't jive with that.
- 3 OFF RECORD DISCUSSION.
- 4 A. I don't jive with that. I don't agree with that.
- 5 BY MR. MAGGARD:
- Q. When you first started at UBB, which it wasn't
- 7 that long ago --- I guess May?
- 8 A. May.
- 9 Q. Can you remember anything about your first day?
- 10 A. It was rough.
- 11 Q. Did they put you right to work?
- 12 A. Yeah.
- 13 Q. What'd they have you do?
- 14 A. Well, I went on the third shift on Three section.
- Overall, just nobody talked to you, really give you
- any information or nothing like that.
- 17 O. Yeah.
- 18 A. Go here and do this.
- 19 Q. Well, can you remember, did they have you
- 20 shoveling belts or ---
- 21 A. No.
- 22 Q. --- build brattices or what did they put you on?
- 23 Was that third shift?
- 24 A. Third shift maintenance.
- 25 O. Maintenance?

- 1 A. Yeah.
- Q. Have you carry some equipment?
- 3 A. Yeah.
- 4 Q. Yeah. How long was it before --- I mean, who was
- 5 the guy responsible for training you about the mine?
- 6 Who did that?
- 7 A. Let's see. When I started there, Homer Wallace
- 8 was the superintendent and --- I can't remember who
- 9 the mine foreman was. They've changed so many times.
- 10 Q. Did they go over plans or anything like that or
- 11 did they wait and do it later on?
- 12 A. Did it later on. Just I guess whenever they felt
- 13 like it.
- Q. Did they do it like an annual refresher?
- 15 A. No. If they had something that pertained to your
- section, they would go over a MMU change or something
- 17 like that, or a spray pattern change on the miners or
- 18 something. They'd give you paperwork on it. But as
- 19 for when you're first starting, going over roof
- 20 control plans and stuff like that, no.
- Q. Okay. When do you recall maybe was the last time
- that you was involved in a fire fighting and
- evacuation drill? Had it been a long time or ---?
- 24 A. When I was on Three section. Massey's mine rescue
- 25 team come up and simulated a fire.

- 1 Q. Now, one thing I didn't ask you about is, like
- when you come up from on the --- what they call 78,
- 3 when you're going up the track, there's a bunch of
- 4 double doors ---
- 5 A. Uh-huh (yes).
- 6 Q. --- up that way. Have you seen those doors open a
- 7 lot?
- 8 A. Not a lot. I've seen --- one set of 'em was
- 9 sitting on a hill kind of downhill. And if you didn't
- 10 have 'em shut really well and the flaps sealed
- 11 together, they would drift open. As for all of 'em
- 12 being open ---.
- Q. What about damage? Was they damaged a lot?
- 14 A. Yeah. It looked like they've been hit a few times
- and the block around them looked pretty rough.
- 16 Q. Did they work on them a lot, have to work on them
- or just when they ---
- 18 A. I don't know.
- 19 Q. --- got in real bad shape or ---?
- 20 A. I guess when they wouldn't open no more.
- 21 MR. MAGGARD:
- 22 I guess that's about all I got.
- 23 Anything, Terry?
- 24 MR. FARLEY:
- 25 I don't think so.

- 1 MR. MAGGARD:
- 2 Okay.
- 3 ATTORNEY BAXTER:
- 4 On behalf of MSHA and the Office of
- 5 Miners' Health, Safety and Training, I want to thank
- 6 you for appearing and answering questions today. Your
- 7 cooperation is very important to the investigation as
- 8 we work to determine the cause of the accident. We
- 9 request that you not discuss your testimony with any
- 10 person aside from your personal representative.
- 11 After questioning other witnesses, we may
- call you if we have any follow-up questions that we
- feel that we need to ask you. If at any time you have
- 14 additional information regarding the accident that you
- would like to provide to us, please contact us at the
- information that was previously provided to you.
- 17 Any statements given by miner witnesses
- to MSHA are considered to be an exercise of statutory
- rights and protected activity under Section 105(c) of
- the Mine Act. If you believe any discharge,
- 21 discrimination or other adverse action is taken
- against you as a result of your cooperation with this
- 23 investigation, you are encouraged to immediately
- contact MSHA and file a complaint under Section 105(c)
- of the Act.

Remedies under the Mine Act include back 1 2 wages and immediate temporary reinstatement to your 3 most recent position with the company, pending the complete investigation of your complaint. In order to 4 5 file such a complaint, you should contact the MSHA District 4 office. For more information concerning 6 7 your rights as a miner under the Mine Act, please visit MSHA's website at www.msha.gov. 8 9 If you wish, you may now go back over any 10 answer you've given during this interview. also make any statement that you'd like to make at 11 12 this time.
