All members of the Mine Safety and Health 4 Administration Accident Investigation Team and all 5 members of the State of West Virginia Accident 6 7 Investigation Teams participating in the investigation 8 of the Upper Big Branch Mine explosion shall keep confidential all information that is gathered from 9 10 each witness who provides a statement until witness 11 statements are officially released. MSHA and the 12 State of West Virginia shall keep this information confidential so that other ongoing enforcement 13 activities are not prejudiced or jeopardized by a 14 premature release of information. 15 This confidentiality requirement shall not preclude 16 17 investigation team members from sharing information with each other or with other law enforcement 18 Everyone's participation in this interview 19 officials. 20 constitutes their agreement to keep this information 21 confidential. 22 Government investigators and specialists have been assigned to investigate the conditions, 23 events and circumstances surrounding the fatalities 24 that occurred at the Upper Big Branch Mine-South on 25

1 April 5th, 2010. The investigation is being conducted 2 by MSHA pursuant to Section 103(a) of the Federal Mine 3 Safety and Health Act and by the West Virginia Office of Miners' Health, Safety and Training. I want to 4 thank you for your appearance here this morning and 5 your assistance in this investigation. 6 7 This is not an adversarial proceeding. Formal Cross Examination is not permitted; however, 8 each of the parties will be able to ask follow-up, 9 10 clarifying questions as we proceed. 11 Your identity and the content of this 12 interview will be made public at the conclusion of the interview process and may be included in a public 13 report of the accident. You may request that your 14 identity be held confidential, and to the extent that 15 we are permitted by law to do so, we will hold that 16 17 --- respect that confidentiality request. However, if a judge or some other law requires that we reveal your 18 19 name, we may be compelled to do so. Also, there may be 20 a need to use the information that you provide to us 21 and other information --- or other information that 22 you may provide to us in the future in other investigations or hearings concerning the explosion. 23 24 Do you understand your right to request 25 confidentiality?
