27. Description of Accident (include equipment involved, the exact location in the mine, and status of rescue and recovery operations):

On July 31, 2013, at approximately 7:00 a.m., a twenty eight year old mechanic, employee of Amerikohl Mining, was fatally injured while trouble shooting a strut on a CAT 773E Rock Truck. The fatally injured victim was found lying between the right front tire and the bottom of the fender. The victim was pronounced dead at the scene by the Indiana County Chief Deputy Coroner. The victim had 7 years and 45 days experience as a mechanic with this mine.

The information provided in this notice is based on preliminary data ONLY and does not represent final determinations regarding the nature of the incident or conclusions regarding the cause of the accident.
