Electrical circuit protection is improperly set at the Longwall Starter on the Headgate 21 longwall section (MMU 050) for the 4160 volt tail drive motor circuit. The circuit does not have the proper ground fault protection of 0.125 amps as approved. The SGF-25 relay was set to trip the vacuum circuit breaker at 0.150 amps. Improper short circuit protection was being applied for the 4160 volt shearer motor. The vacuum circuit breaker was set to trip at 2610 amps instead of the required 1730 amps. Improper overload protection is being provided for the 4160 volt #2 stageloader motor. The full load current value input to the 239-AN relay is set approximately 112 amps higher than the required setting.
