The AEEI transformer (serial #11521-500-398) is not being properly maintained, in that;

(1) high voltage cables are entering/exiting the transformer. As of 04.05.2010, it was being used as a Splice box, instead of a transformer. The electrical map has it listed as "OUT OF SERVICE". This transformer is located along the track at crosscut # 120 of the North Mains. The disconnects are open. The cited condition could lead a miner to think the transformer is not energized, resulting in a shock hazard.

This transformer is located in an area affected by an explosion on 04.05.2010. The Operator is issued a high number of similar citations upon inspection of the underground electrical equipment, following the accident.
