The CO sensor spacing along the Head gate 22 section belt conveyor is greater than 1000 feet. The maps with the locations of the CO sensors does not indicate sensors along the belt conveyor. (Citation 8405583 was issued on the electrical/CO map.) The map display on the Pyott-Boone AMS system display indicates there were 3 sensors located along the belt conveyor. The belt conveyor for the drive to the tail is approximately 3750 feet in length from the Head drive CO sensor to the tail drive sensor. The evidence indicates the spacing between sensors exceeds the 1000 feet limit for CO spacing. The lack of sensors exposes miners to the hazard of CO from belt fires. The belt examination records indicate there were accumulations of coal dust along the conveyor increasing the risk of belt conveyor fires.
