Nevada Gold Mines LLC ("NGM") respectfully submits its comments on the Mine Safety and Health Administration's ("MSHA") proposal to amend its existing standards to better protect miners against occupational exposure to respirable crystalline silica and to improve respiratory protection for all hazards as set forth in the proposed rule entitled "Lowering Miners' Exposure to Respirable Crystalline Silica and Improving Respiratory Protection," 88 Fed. Reg. 44582 (July 13, 2023). NGM supports the proposed reduction in the permissible exposure level for respirable crystalline silica but has concerns about its implementation.

NGM is a joint venture between Barrick Gold Corporation and Newmont Corporation. In addition to other mines and facilities, NGM operates 9 underground gold mines in Northeastern Nevada. These include the Meikle Mine, Turquoise Ridge, Leeville, Cortez, Exodus, Pete Bajo, Twin Underground, Goldrush, and El Nino.
